- 3.1 The Bid should be submitted in sealed covers super-scribed TENDER FOR HIRING OF VEHICL AT SHIMLA.
- 3.2 The Bid will be opened on 11 May, 2022 at 04.00 pm. in the presence of the bidders or their authorized representatives in the Sahitya Akademi's Conference Hall at the 3rd Floor.
- 3.3 The Committee shall assess the ability of the agencies to carry out the requisite quality work, profile and experience in the field.
- 3.4 The decision of the Secretary, Sahitya Akademi who is the Competent Authority in the Sahitya Akademi shall be final and abiding.

- No advance Payment will be made through PFMS (Public Financial Management System) on submission of the bill on successful checked out duly certified/recommended by the Committee constituted for this purpose.
- 5. The contract for providing vehicles will be given to the lowest bidder who fulfils all the terms Conditions given in the tender document. To safeguard against failure by the successful Service provided in providing requisite number of Vehicles, this office may empanel other Service providers who are capable to provide service as per the same terms and conditions as that of L-1(Firm who has quoted the lowest rates), tenderer.
- 6. This office reserves the right to revise the requirements of vehicles being hired depending upon the actual requirement. A daily Record indicating time and mileage for each vehicle shall be maintained in a log-book which Should be submitted to the Sahitya Akademi for scrutiny and payment of bills.
- The vehicles should have all necessary permission from the Transport department including the Pollution certificates issued by the Competent Authority.

- The driver(s) deputed on duty should carry valid driving license and do not have any Police Records/criminal cases against them.
- Tenderers shall not be permitted to withdraw offer or modify the terms and conditions thereof at any time during the process of finalizing the award of work/contract/job. In case the tenderer fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the afore said amount of EARNEST MONEY DEPOSIT (EMD) will stand forfeited to the Sahitya Akademi.
- No claim shall lay against Sahitya Akademi in respect of erosion in value or interest on Earnest Money Deposit and for any challan/loss/damage or any accident of the vehicle or for the injury of any other third party.  - 13.1 In the event of breach of contract or negligence or non-observance of any condition of contract or for unsatisfactory performance i.e. contrary to the contract, the performance security can be forfeited on the approval of the Competent Authority in the Sahitya Akademi.
 - 13.2 On expiry of the contract, such portion of the said security deposit as may be considered by the Competent Authority of the Sahitya Akademi sufficient to cover any incorrect or excess payments made on the bills to the firm shall be retained until the final report of the Committee on account of firm's bill has been received and examined.
 - 14. Penalty: In case the bidder fails to arrange the required rooms at the satisfaction of the Akademi the Competent Authority in the Sahitya Akademi) would be deducted 2% of the contracted value from the amount payable to the Agency.
 - 15. - Subletting of work: The tender is not transferrable. The firm shall not assign or sublet 18. the work/job or any part of it to any other person or party. Only one tender shall be submitted by one bidder.
- Right to call upon information regarding status of work: The Competent Authority of 19. Sahitya Akademi will have the right to call upon information regarding status of work/job at any point of time after having awarded the contract.

- 21. Arbitration: If any difference arises concerning this Agreement, its interpretation on the payment to be made there under, the same shall be settled by mutual consultations and negotiations. If attempts for conciliation do not yield any results within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an arbitral tribunal containing Sole Arbitrator to be appointed by the President, Sahitya Akademi. Such request shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The arbitration proceedings shall take place at New Delhi and shall be conducted in English. The provisions of Arbitration and Conciliation Act and the rules framed there under and in force shall be applicable to such proceedings.
- 22. <u>Legal jurisdiction</u>: The agreement shall be deemed to have been concluded in the National Capital Territory of Delhi and all obligations hereunder shall be deemed to be located at the NCT of Delhi and the Court within NCT of Delhi will have jurisdiction to the exclusion of all other Courts.
