#### **TERMS AND CONDITIONS**

- 1. The tender shall be submitted with conceptualization, design in hard as well as soft copy along with the rates.
- 2. If the cover of the Tender is not sealed and marked, the Sahitya Akademi will assume no responsibility for the Tender's misplacement or premature opening.
- 3. The Tender should clarify whether the individual signing the Tender or other documents in connection with the tender signs as:
- 3.1 A "sole proprietor" of the firm or constituted attorney of such sole proprietor, or
- 3.2 A partner of the firm if it be a partnership in which case he must have authority to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or a power of attorney. In the alternative, the tender should be signed by all the partners, or
- 3.3 Constituted Attorney if it is a company.
- 3.4 The tender should be signed either by the proprietor or by his authorized representative. In case of the later, an authority letter should be enclosed with the tender.
- 4. Incomplete tender are liable to be rejected...
- 5. The quantities mentioned in the schedule may either be increased or reduced at the discretion of the Sahitya Akademi. However, for the reduced quantity no claim shall be entertained and if considered necessary, any item could be dropped completely.
- 6. The tender should fill the rates both in figures as well as in words. The tender form may be filled in English and all entries must be handwritten in ink. Overwriting of rates is not permitted. Corrections, if any, should be authorised by the tenderer/bidder with his initials.

- 7. If there is a discrepancy in rates between words and figures, the amount in words will prevail.
- 8. When deemed necessary, the Sahitya Akademi may seek clarification on any aspect from the tenderer. However, that would not entitle the tenderer to change or cause any change in the price quoted. The Sahitya Akademi may, if so desired, ask the Tenderer to give presentation for the purposes of clarification of the tender. All expenses for this purpose as also for the preparation of documents and other meetings will be borne by the tenderer.
- 9. The minimum turnover of the contractor should be at least Rs.50.00 (Fifty lacs) per annum during the last three years.
- 10. The Sahitya Akademi will examine the tender to determine whether the same are complete, whether any computational errors have been made, whether the documents have been properly signed, and whether the tenders are generally in order.
- 11. A tender determined as not substantially responsive will be rejected by the Sahitya Akademi and may not subsequently be made responsive by the tenderer by correction of the non-conformity.
- 12. The Sahitya Akademi may waive any minor infirmity or non-conformity in the tender which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of other tender. The decision of the Sahitya Akademi in this regard will however be final.

#### 13. **Liquidated Damages**

Work must be completed by 26 June 2015 upto 11.00 a.m. in all respect from the date of receipt of work order. Failure to do so will entitle the Sahitya Akademi to impose a penalty of Rs.5,000.00 per hour on the contractor and he may be blacklisted for future work. In addition to it the Performance Guarantee deposits shall stand forfeited. Further, failure on the part of the contractor to complete the job in accordance with the terms and conditions set out and within the time schedule will confer on the Sahitya Akademi the right to get the work done through another contractor, under such circumstances, the entire cost/ damages so incurred by the Sahitya Akademi will have to be borne by the first contractor.

- 14. The contractor shall engage technically competent personnel for executing the work.
- 15. The Sahitya Akademi will award the contract to the tenderer whose tender has been determined to be substantially responsive and has been determined as the lowest evaluated bid, provided further that the tenderer is determined to be qualified to perform the contract satisfactorily.

- 16. Before award of the contract the successful tenderer will be required to deposit Performance Security (refundable) a sum equivalent to 10% of the value of the contract in the form of a Demand Draft drawn in favour of Secretary, Sahitya Akademi payable at Delhi. The Performance Security deposit shall be released by the Sahitya Akademi after successful completion of the contract in all respects.
- 17. The security money shall be forfeited in the event the contractor either fails to complete the job within the stipulated time or if the job is not done satisfactorily as per the specifications. If the successful tenderer backs out after award of the contract, Performance Guarantee is liable to be forfeited.
- 18. During the period of construction of Sahitya Akademi's Book shop, the contractor shall have to make his own arrangement for various amenities necessary for the smooth execution of his work.
- 19. The contractor will be responsible for the up-keep and maintenance of the entire structure of Sahitya Akademi Shop constructed at Metro Station, for which no extra payment shall be made. Breakage and damages, if any, shall immediately be replaced/repaired without any extra cost by contractor.
- 20. The payment of the billed amount will be made subject to a physical verification by the officers of the Sahitya Akademi.
- 21. Documentary evidence of the tender being a registered/approved contractor and of his having done work of a similar nature in India and abroad.
- 22. Income tax shall be deducted at source as applicable under the rules. **Permanent**Account Number (PAN) allotted by the Income Tax Authorities must be quoted in Annexure 1, without which the tender is liable to be rejected.
- 23. The Sahitya Akademi reserves the right to accept or reject any tender, and to annul the tender process and to reject all bids at any time prior to the award of the contract, without thereby incurring any liability to the affected tender or tenders on the grounds for Sahitya Akademi action.
- 24. The decision of the Sahitya Akademi in this regard would be final and binding.
- 25. The Sahitya Akademi and the contractor shall make every effort to resolve amicably by direct informal negotiations any disagreement or dispute, arising between them under or in connection with the contract. However, any unresolved disputes would be subjected to the jurisdiction of Delhi courts only.
- 26. Any loss to the Sahitya Akademi due to the negligence/lapse on the part of the contractor shall be borne by the contractor. Alternatively, the amount of loss will be deducted from the amounts payable to the contractor.

- 27. All bidders should submit a **self undertaking** that they have never been blacklisted by any Government of India Ministry/ Department/ Authority/ Organisation/ Agency.
- 28. **Details of any awards** won for stand design in the past three years.
- 29. The Sahitya Akademi reserves the right to accept/reject any/all the tenders without assigning any reason.

#### **Arbitration**

30. That it has been mutually agreed between the Secretary, Sahitya Akademi and the Firm/Supplier that any dispute arising out of this acceptance shall be referred to for Arbitration to the Secretary, Sahitya Akademi address and his decision shall be binding on the Firm/Vendor. The Firm/Vendor shall not raise any question of competence of Secretary, Sahitya Akademi do act as sole Arbitrator.

## **Legal Jurisdiction**

31. Any legal dispute will be subject to jurisdiction of Delhi Courts and no other Court shall have the jurisdiction.

#### Validity of the bid

1. The bid submitted by the tender's shall be valid for a minimum period of 90 days computed from the date of opening of the bid.

#### 2. Selection Criteria

- 2(i) Conceptualization of design, interior and exterior will carry a wait age of 70 marks, financial bids will carry weightage of 30 marks. The agencies scoring 70 per cent marks (49 marks) or above in Conceptualization of design, interior and exterior shall be eligible for opening of their financial bids.
- **2(ii)** The financial bids of **only** those agencies that score 70 per cent mark (49 marks) or above in Conceptualization of design, interior and exterior will be opened in the presence of their representatives. The date and time of opening of the financial bids will be conveyed to the selected agencies. Financial evaluation will carry a weight age of **30 Marks**.
- **2(iii)** The agency which scores the highest aggregate marks on the basis of Conceptualization of design, interior and exterior and financial evaluation (after adding the scores of the both the submission) will be awarded the contract for Conceptualization of design, interior and exterior.



#### Specifications for Electrical Works



- 1. Licensee is required to prepare all the plans/drawings for Electrical & Fire work to be carried by them and obtain prior approval of DMRC before execution. The work is required to be executed as per IE rules and through a licensed Sub Contractor. All costs associated with provision of electricity shall be borne solely by the Licensee. The Licensee hereby voluntarily and unequivocally agrees not to seek any claim, damages, compensation or any other consideration whatsoever on account of time and cost associated in making provision of electricity.
- 2. For Elevated station load up to 10 KVA shall given in single phase & in case of underground stations load up to 5 KVA shall be given. Load above this it shall only be given in three phase. License is required to balance load at his end so that no unbalancing occurs at DMRC end.
- 3. Cables up to 6 Sq.mm. shall be of copper conductor and above 6 Sq.mm. Aluminum conductors may be used. However in case of underground station use of Aluminum conductor cable is not allowed. Cables for single phase shall be three core, with one core as earth. For three phase load four core cable along with separate 2 nos. of 8 SWG GI wires shall be used for earthing. For underground stations 2 separate earth wire of 8 SWG copper conductor shall be used.
- 4. For elevated stations all wires shall be FRLS. Cables shall be armoured, XLPE, FRLS. In case of Underground stations all wires and cables shall be armoured, XLPE FRLSZH and conform to NFPA-70, BS-6724 and BS6724.
- 5. The meter along with MCB & ELCB box shall be metallic and without any holes. DP MCB & ELCB is required for single phase supply. TPN MCB and ELCB are required in case of three phases. ELCB, cables, MCB rating for main connection shall be as per below table-1.
- 6. Use of any PVC material is not permitted in the underground stations.
- 7. Licensee shall provide a separate protection for their electric requirement with proper discrimination with upstream breaker.
- 8. All materials specification must follow standards, codes and specification as used by DMRC in the E&M works.
- 9. In case, the Licensee draws power more than the sanctioned load, electricity connection may be disconnected. The electricity connection shall be restored on first occasion only when Licensee pays necessary penalty as per DERC norms and removes excess load. On the subsequent occasion, DMRC reserves the rights to revoke the license and forfeited the interest free security deposit.
